3. 22-053 - Resolution F-026 - Purple Pipe Project DOE Agreement No. WQC-2022-Cheney-00151

The City received a \$21,823,000 loan from the Department of Ecology in 2021. The City has also received \$13,000,000 in direct appropriation grants from Washington State. Currently, the city has applied for a federal grant in the amount of \$5,455,750 and should know the results later this spring. The loan agreement is through June 2026 and would only apply to the remaining expenditures over and above current and future grants received for construction of the Cheney Purple Pipe Project.
