

REGULAR CITY COUNCIL MEETING

April 26, 2022

A. Call to Order – Pledge of Allegiance Mayor Grover called the Regular City Council meeting to order at 6:00 p.m.

B. J. Action Items

2. 22-046 – Resolution F-020 – Interagency Agreement Between AOC and Cheney Municipal Court for Interpreter Funding Ms. Cooper stated that this agreement allows us to recoup costs we may spend for interpreters. There is no cost. Councilmember Schmidt moved for approval of Resolution F-020. Councilmember Posthuma seconded. Carried unanimously.

3. 22-053 – Resolution F-026 – Purple Pipe Project DOE Agreement No. WQC-2022-Cheney-151 Mr. Ableman explained the agreement and the project. Councilmember Weiszmann moved for approval of Resolution F-026. Councilmember Gaard seconded. Carried with Councilmember Barthels abstaining.

4. 22-055 – Resolution F-028 – One Washington Memorandum of Understanding Mr. Schuller explained the MOU and spoke about opioids. Councilmember Schmidt moved for approval of Resolution F-028. Councilmember Gaard seconded. Carried unanimously.

Councilmember Gaard stated that it is exciting to be part of the Cheney Depot Society. He appreciated the citizen participation. Councilmember Hilton will be attending Bloomsday. Councilmember Posthuma enjoyed the comments from the citizens. He stated that Mayfest is next weekend.
